

Insurance

Insurance cover is an important feature of your fair participation. Ordinary business insurance does not cover exhibiting at trade fairs. Separate transport and exhibition insurance is usually very expensive and also provides less cover than our exhibition insurance. The liability of freight carriers is also very limited. Stockholmsmässan, in association with Länsförsäkringar SAK AB, has developed the market's best and simplest exhibitor insurance.

CONTENT

- Your goods are fully insured during transport to and from Stockholmsmässan, including loading and unloading.
- Your goods are fully insured during the exhibition, including installation and dismantling.
- The insurance covers all transport to and from Stockholmsmässan within the EU/EFTA. For policy holders outside the EU/EFTA, the insurance is only valid on the exhibition site.
- You also have good cover for personal luggage, as well as costs incurred in the event of illnesses and accidents.
- The insured value is 225,000 SEK, but you can take out additional insurance for a higher value.
- The insurance also includes liability insurance.
- The excess is 1,000 SEK per injury/theft. In the event of a break-in or theft from private vehicles/trailers, the excess will be 20% of the amount of loss (minimum SEK 5,000).
- Additional costs due to injury are included at up to 10% of the insurance value.
- The insurance covers exhibitors, co-exhibitors and companies represented in your stand.
